REQUIREMENTS TO SUBMIT THE OFFER

Any person, natural or legal, in full capacity to understand and want, may participate in the tender, provided there are no conditions of incapacity to contract with the Public Administration, as well as any other situation considered by the local legislation prejudicial to the capacity to contract.

SUBMISSION OF OFFERS

The submission of offers can only take place through the use of the attached model, under penalty of exclusion, which must be signed.

The offer can be made in Italian, English or Arabic.

The bidder must attach a copy of a valid identity document.

The offers must be, under penalty of exclusion, presented in a sealed envelope and with the following inscription:

The envelopes containing the offers and the related documentation must be received no later than 12.00 pm, on 7 of November, 2023 in one of the following ways:

For the purposes of the deadline set for the submission of offers, only the receipt stamp affixed on the aforementioned package by the Embassy will be considered as proof.

The price, under penalty of exclusion, must be indicated in numbers and letters. In case of discrepancy between numbers and letters, the most favorable price at the Embassy will be considered prevailing and valid.

OPENING OF OFFERS

A commission set up for this purpose will open the envelopes and evaluate the offers, at the Italian Embassy Muscat, Way 3034 - House n. 2697 - Shatti Al Qurum, P.O. Box 520 - PC 115 Madinat Al Sultan Qaboos (Sultanate of Oman), on **November 8, 2023, at 11.00 am**, in an open public session only to those who have submitted an offer in good time.

It is possible to delegate through a written power of attorney.

The chosen bidder will be invited to sign the contract.

In case of renunciation of the selected bidder to sign the contract within the required time, he will lose the right to purchase. The Embassy reserves the right to evaluate the assignment to the next bidder in the ranking or whether to initiate a new procedure.

Should two or more bidders propose the same amount, the Embassy will invite them to propose a new offer within a reasonable time.

All communications to the participants will be made via the email indicated by them in the participation form.

TERMS OF SALE

The car is sold in the state of fact and law in which it is found.

All expenses, none excluded, relating to transport, maintenance, overhaul, registration fees and any other emolument that was due for any reason for the

transfer of ownership or to make the car usable, will be at the sole responsibility of the buyer. No claim, appeal or return request will be accepted.

The Embassy will be considered totally free from any responsibility regarding the state of maintenance of the vehicle or the administrative procedures relating to the transfer of ownership.

The delivery of the vehicle will take place only after the completion of the following procedures:

- Signing of the sales contract;
- Payment of the agreed sum to the account of the Embassy;
- Change of ownership.
